Light Vehicle Replacement	2017/1	£0	£90k	March 2020	Martin Barclay	Three Hyundai Kona electric vehicles are in use and have proven to meet our light vehicle needs, though the range of 170 miles can be a limiting factor for use in the wider fleet e.g. Group Support Team who do more mileage and are more remote so do not have reliable access to charging points. The imminent launch of new electric vehicles, including the Renault Zoe (245 miles), Vauxhall Corsa (205 miles) and Peugeot 208 (205 miles) with improved mileage range will increase availability options and it is anticipated that future vehicle purchases will be of this capacity. A demo Zoe is due end of Jan 2020 and is affordable which will form basis for decision making. The higher range Hyundai Kona (270 miles) prices have gone up considerably making this unaffordable so have been omitted from the options list. It has been identified that the additional cost of an electric vehicle will be recovered in fuel savings over approximately 60,000 miles, with further saving achieved in maintenance costs. Future resale values in comparison to petrol or diesel cars are not available for the planned 7-year life of an EV light vehicle.

Replacement Appliances	2017/1	£81	£681k	December 2019	Martin Barclay	Five appliances have been delivered and are now in use at Shrewsbury x2, Telford x2 and Baschurch. 2 ex wholetime vehicles are currently being refurbished with additional seats added for on-call use or use in the reserve fleet. 1 appliance will have a refurbishment only and be cascaded into the training department. The work has now started for the purchase of five new appliances, the type of which will fall out of the work being done by Ops into smaller appliances or the standard larger appliance with more foam capability, or a mix of both types.
