

Annual Review of Charges for Special Services

1 Purpose of Report

This report presents proposed increases in charges made for special services.

2 Recommendations

The Fire Authority is asked to:

- a) consider and decide upon the proposed charges for special services to be applied from 1 April 2024, and
- b) delegate this exercise to officers, with future exceptions referred back to the Authority.

3 Background

Charging for special services is currently permitted by Orders issued under Section 18 parts a, b and c of the Fire and Rescue Services Act 2004. This report lays out proposed increases to the current tariff of charges.

The charges for special services are reviewed annually.

4 Annual Review

It is proposed that the remaining charges on the tariff are increased by 5%, the pay increase which was awarded to firefighters in 2024/25.

As application of firefighter pay is the standard method of increasing the special services tariff, the Authority is asked to delegate this annual increase to officers, with any future exceptions from this approach brought to members.

5 Financial Implications

There are no financial implications arising directly from this report other than those discussed within the report.

6 Legal Comment

The Fire Authority has the power to impose special charges only in certain circumstances.
