# Non-Pecuniary Interests

  - (i) Exercising functions of a public nature
  - (ii) Any body directed to charitable purposes or
  - (iii) One of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)
- c) A matter that *directly relates* to your financial interest or well-being (and is not a Disclosable Pecuniary Interest set out in Table 1) or a financial interest or well-being of a relative or close associate
- d) A matter that affects:
  - a. Your own financial interest or well-being
  - b. A financial interest or well-being of a relative, close associate; or
  - c. A body included in those you need to disclose under non-pecuniary interests, as set out in this paragraph.

# Notes on sensitive interests

An interest is sensitive if you and the Monitoring Officer agree that its disclosure could lead to you, or a person connected with you, being subject to violence or intimidation.
