Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest⁴) and the Authority —

(a) under which goods or services are to be provided or works are to be executed; and

(b) which has not been fully discharged.

- d) A matter that affects:
 - a. Your own financial interest or well-being
 - b. A financial interest or well-being of a relative, close associate; or
 - c. A body included in those you need to disclose under non-pecuniary interests, as set out in this paragraph.
