<sup>4 &</sup>quot;body in which the relevant person has a beneficial interest" means a firm, in which you or your partner is a partner or a body corporate, of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest; and "director" includes a member of the committee of management of an industrial and provident society

- b) Any body
  - (i) Exercising functions of a public nature
  - (ii) Any body directed to charitable purposes or
  - (iii) One of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)
- c) A matter that *directly relates* to your financial interest or well-being (and is not a Disclosable Pecuniary Interest set out in Table 1) or a financial interest or well-being of a relative or close associate
- d) A matter that affects:
  - a. Your own financial interest or well-being
  - b. A financial interest or well-being of a relative, close associate; or
  - c. A body included in those you need to disclose under non-pecuniary interests, as set out in this paragraph.

#### Notes on sensitive interests
