 - (iii) One of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)
- A matter that directly relates to your financial interest or well-being (and is not a Disclosable Pecuniary Interest set out in Table 1) or a financial interest or well-being of a relative or close associate
- d) A matter that affects:
 - a. Your own financial interest or well-being
 - b. A financial interest or well-being of a relative, close associate; or
 - c. A body included in those you need to disclose under non-pecuniary interests, as set out in this paragraph.

Notes on sensitive interests
