<p><b>Contracts</b> Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest<sup>4</sup>) and the Authority — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.</p> <p>None</p>

  - (iii) One of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)
- c) A matter that **directly relates** to your financial interest or well-being (and is not a Disclosable Pecuniary Interest set out in Table 1) or a financial interest or well-being of a relative or close associate
- d) A matter that affects: -
  - a. Your own financial interest or well-being
  - b. A financial interest or well-being of a relative, close associate; or
  - c. A body included in those you need to disclose under non-pecuniary interests, as set out in this paragraph.
