1 Purpose of Report

This report is part of the regular monitoring process undertaken throughout the year. It details the latest position on revenue and capital budgets, recommending action where necessary.

2 Recommendations

The Committee is asked to:

- a) Note progress on the revenue budget;
- b) Recommend that the Fire Authority approve the virements shown at paragraph 4; and
- c) Note progress on the Fire Authority's capital programme.

3 Background

As part of the regular monthly monitoring of the revenue budget, carried out by officers, net underspends were moved to balances following Fire Authority approval in October and December 2006, and February 2007.

This paper reports further movements as a result of monitoring to the end of January 2007.

Progress on the Fire Authority's capital programme for 2006/07 is also reported.



4 Revenue Budget Monitoring

The Net total is a £7,000 underspend. Other information, not yet costed, is that legal costs for the Retained Firefighters and Part-Time Workers (Prevention of Less Favourable Treatment) Regulations Employment Tribunal will be allocated to authorities under the agreed cost-sharing arrangements. It is hoped that this can be contained within the net underspend.



5 Capital Programme

Work is progressing on the schemes within the 2006/07 programme, with expenditure in January on Information Technology and building improvements.

An order has been placed for building improvements at Prees. Work has begun on procuring an Asset tracking system, and some refurbishment has been done on the Authority's training facilities.
