1 Purpose of Report

The purpose of this report is to provide an overview of all the capital schemes within the Brigade and their current status.

2 Recommendations

The Committee is asked to note the progress on Capital Schemes

3 Background

Following a review of the Capital Schemes for the previous year, current year and two further years, executive officers recommended a way forward for the Schemes. This was agreed by Members at the Fire Authority meeting in July 2008. Members also agreed that monitoring reports on activity and finance for this year's schemes (08/09) should be received by the Strategy and Resources Committee. This is the first update on the progress of those schemes and brings together details of activities and finance for each scheme from April to the end of August.

4 Progress

The table in the appendix shows progress on schemes brought forward from 2007/08 and those scheduled for 2008/09. It also identifies those schemes managed under PRINCE2.

As yet a large number of schemes are unable to report any projected under or over spend, as schemes have not yet started. As reporting on the Capital Schemes progresses throughout the year, further information is expected.



Most notably:

- Schemes 12 (Training Improvements £92.1k) and 22 (Training Facilities £30k) will be delivered jointly; an appraisal detailing the use of the capital is the subject of a further report.
- Scheme 15 (Telford Lecture Room £40k) is currently being reviewed and recommendations will be returned to a future meeting of the Strategy and Resources Committee.

Conversely a number of schemes have now been completed and these are indicated in the appendix.
